### 2021-2022 TUITION and FEES

Tuition at Cornerstone Christian School is competitive with other evangelical schools in the metropolitan area. We are committed to provide our families the best value possible without compromising the quality of our programs or the efficiency of operation.

A registration/application fee of **\$125.00** (new student), **\$75.00** (re-registration), and a **\$75.00** curriculum fee is payable upon acceptance for admission. The registration fee is refundable *only in cases where a class has been closed*.

**NOTE: Tuition must be paid by the following options.**

\*Monthly tuition payments are made through *FACTS Tuition Management*. Tuition payments begin promptly in July each year. This is a direct withdrawal from a checking or savings account. See Registration Packet.

**IMPORTANT:** Registration applications, submitted after July, will be required to pay the outstanding tuition payments, before attending school.

**The following fee schedule is in effect for the 2021-2022 School Year:**

Application/Registration Fee (new students only) .....	\$125 ( <i>per child</i> )
Registration Fee (returning students).....	\$ 75 ( <i>per child</i> )
Curriculum Fee .....	\$ 75 ( <i>per child</i> )
Late Registration Fee (returning students <b>after</b> April 1 <sup>st</sup> ) .....	\$125 ( <i>per child</i> )
Insufficient Funds Check Fee .....	\$35 ( <i>per check</i> )

**LATE FEE and OVERDUE ACCOUNTS**

In the event an account becomes overdue, Cornerstone Christian School will continue to hold the parents responsible for satisfying the account. If personal or financial difficulties prevent parents from making payments on or before due dates, they should advise the Cornerstone Finance 845-637-3439, immediately. Report cards and records will be withheld until payments are satisfied.

Children of parents with delinquent accounts, over **60 days**, will not be permitted to attend school until the parents have made arrangements to pay the overdue account. If extenuating circumstances prevail, parents may make an appeal in writing to the administrator.

**WITHDRAWALS and REFUNDS**

When a pupil is dismissed or withdrawn from the school for any reason, tuition must be paid in full for each calendar month that the pupil was in attendance at the school. In the event tuition has been paid beyond that month of dismissal or withdrawal, Cornerstone Christian School will refund the parents accordingly.
