However, I understand that when it comes to questions and answers, the clarity of both is better when done in person. For that reason, I have planned an informational meeting for our parents. The meeting will take place outdoors in our South Side Parking Lot on September 8, 2020 at 6:00pm. Our school nurse will be present as well as all of our faculty and staff. You will be able to ask your questions in person to our school nurse, as well as myself. I will also introduce our faculty and school staff.

****Please note that we will be following all of the CDC guidelines as specified below:**

Please be aware that any individual who displays symptoms consistent with COVID-19, has tested positive for COVID-19 within the last 14 days, or within the 14 days had close or proximate contact of an individual who had symptoms of COVID-19 or tested positive for COVID-19 is, not permitted to attend the meeting.

- All attendees at the gathering are required to remain six feet apart from other attendees at all the times, excluding immediate family members or household members.
- All chairs for students, guests, and staff will be situated six feet apart.
- All Attendees at the gathering must wear a mask or face covering.
- There will be no person-to-person contact during the meeting. Individuals may not shake hands.
- CDC protocol of cleaning and disinfecting of chairs, microphone, etc. will be adhered to.

In order to adhere to the guidelines established by NYSED and the CDC, we will be limiting the length of our meeting. This will shorten the time that individuals are exposed to each other. I also ask that you be mindful; we are still dealing with the COVID-19 pandemic, and for that reason CCS is asking that you limit the number of family members attending this meeting.

Please be aware of the following:

LUNCH

- We are asking all parents to send in a healthy lunch for their child **until further notice**. Students must come in the morning with their lunch. No lunch is accepted at lunch time. Please do not have lunch delivered to the school during the day. We are ***minimizing all entry*** into the school building to keep our students and staff safe.

AFTERCARE

- If you are interested in AfterCare, please fill out the registration form attached and email it to the office ASAP. This will let us know if you are interested. Payment is due the first day of school. We are working on the details of this program.

TRANSPORTATION

- Please call your school district's transportation department for all busing information. All districts are aware that our school doors will be opening on September 9th.

SCHOOL SUPPLIES

- You may drop off your child's school supplies this week (Tuesday, Wednesday, or Thursday) between the hours of 10AM – 2PM.
